RELEASE OF LIABILITY PLEASE READ

In order to participate in any horse activity on Stenerston Ranch, you must read this completely and agree to all of its contents. If not, you will not be allowed to participate in any way with horses or any other activities on Stenerston Ranch property. This is a contract. Please read the entire release before signing. Parents must sign if they have children under the age of 18 participating in any way with on the ranch property. Please initial next to each paragraph that you have read and agreed to its contents and sign your full legal name at the bottom.

_____ I acknowledge that horseback riding and barrel racing is a dangerous sport, which carries inherent risks of injury and damage to myself, my horse and/or property. I am voluntarily participating in this activity with the knowledge of the danger involved. I acknowledge that I am voluntarily participating at an event with horses, and that horses are animals, and that animals are unpredictable. **I ASSUME ALL RISKS, WHETHER KNOWN OR UNKNOWN, OF HORSEBACK RIDING WITH STENERSON RANCH AND THEIR OWNERS.**

ALSO, I RELEASE STENERSON RANCH, ANY VOLUNTEERS AND ARENA OWNERS FROM ANY AND ALL LIABILITY FOR ANY ACT OF NEGLIGENCE OR WANT OF ORDINARY CARE ON THE PART OF THE RANCH OR ANY OF ITS AGENTS. In

consideration of my participation in events organized by Stenerston Ranch, I waive, release and discharge, Stenerston Ranch and its owners, their representatives, heirs, executors and assigns, from any and all claim or liability for injury or damage to myself, my horses, or my property arising out of my participation. This agreement is binding on my execution, heirs and assigns.

_____ I expressly waive the rights I may have under California Civil Code 1542, which states: "a general release does not extend to claims which the creditor does not know or suspect to exist in his/her favor at the time of executing the release, which if known by him/her, must have materially affected his settlement with the doctor."

_____ I agree that I will defend, indemnify, and hold harmless Stenerston Ranch against any and all claims, demands and causes of action, including court costs and actual attorney fees, arising from any proceeding or lawsuit brought by or prosecuted for my benefit, in which this release is upheld.

_____ I acknowledge that I have read this RELEASE OF LIABILITY, and know and understand its contents, and I, the undersigned parent, guardian or chaperone or the minor children in my family as listed on reverse, in consideration of the child's/children's participation in any horse related activity, agree that the terms and conditions of the Release of Liability shall be binding as to damage or injury to my child/children, their horses, and property, arising out of their participation in this activity.

_____ I have carefully read this agreement and acknowledge that this is a release of liability and a contract between myself and Stenerston Ranch, and that I fully understand the contents of this release of liability, and that I am of sound body and mind, and am signing this contract of my own free will.
